THE KISII COUNTY FINANCE Bill, 2025**No. 3 of 2025**

A BILL of the County Assembly of Kisii, to provide for the various levies, fees and charges for services, and for other revenue raising measures by the County Government and for matters incidental thereto

ENACTED by the County Assembly of Kisii as follows—

PART I**PRELIMINARY****Short title**

1. This Bill may be cited as the Kisii County Finance Bill 2025 and shall come into operation on the seventh day after the date of publication in the Kenya Gazette. The County Executive Committee Member for Finance may through a Gazette notice appoint different dates for different provisions.

2. In this Bill the following terms have the following definitions assigned to them

“Administrative ward” shall denote areas represented by Member of County Assembly;

“Business” means—

- a) Trade, commerce or manufacture, profession, vocation or occupation;
- b) Any other activity in the nature of trade, commerce or manufacture, profession, vocation or occupation;
- c) Any activity carried on by a person continuously or regularly, whether or not for gain or profit and which involves, in part or in whole, the supply of goods or services for consideration.

“Business Code” means unique code issued to every class of source of revenue stream for the purpose of revenue collection.

“Cess” means tax or fees chargeable on raw goods as specified under various schedules in this Bill and shall include a special levy on value added products to promote the growth of the industry, factories and shall include but is not limited to agricultural product fees, factory cess, mining cess, soapstone cess;

“Chief Officer” means County Chief Officer for Finance, Accounting services and Revenue Management;

“County” means the County Government of Kisii;

“Contribution in lieu of rates (CILOR)” means a charge payable by National government agencies to the Kisii county government for the spaces they occupy;

“County Receiver of Revenue” means the person appointed pursuant to section 157 of the Public Finance Management Act, 2012;

“Departments” means units within ministries with revenue component headed by a director e.g., Trade, Lands, Environment, public health etc;

“Revenue Collector” means the county public officer appointed pursuant to section 158 of the Public Finance Management Act, 2012 for the purpose of collecting revenue for the County Government and remitting it to the County Receiver of Revenue;

“Revenue Director” means overall officer in charge of a revenue directorate in the County;

“Revenue Directorate” shall mean a section of the department of Finance charged with the sole responsibility of revenue management in the County headed by the Chief Officer/

Revenue Director as the case may be;

“Executive Committee Member” means Executive Committee Member responsible matters related to Finance at the time;

“Factory” means an industrial site where workers manufacture goods or operating machine processing one product to another;

“Levy” means various taxes, fees and other service charges that are imposed and payable to the County Government of Kisii;

“Kisii Municipality Revenue Officer” means Officer in charge of revenue mobilization and collection within the boundary of Kisii Municipality;

“Kisii Municipality” refers to the area as is determined by the Kisii Municipality Charter.

“Licence/ Permit” shall refer to authorization for any person to conduct a particular business or line of business within a certain jurisdiction within the County;

“Ministry” shall mean a division headed by the County Executive Committee Member (CECM);

“Ogembo Municipality” refers to the area as is determined by the Ogembo Municipality Charter;

“Person” shall mean a natural or artificial or juristic person;

“Region” shall mean an area demarcated within Kisii Municipality headed by a Revenue Officer;

“Region Code” means the unique number given to a region; “Sub- County Revenue Officer” means Officer in charge of revenue mobilization; collection and management at sub county within Kisii County;

“Sub-county” denotes the area represented by a member of the National Assembly excluding where Municipalities cover as defined in their respective charters. In this bill Sub-counties and shall be:

- A. Bobasi Constituency
- B. Bomachoge Borabu Constituency
- C. Bomachoge Chache Constituency
- D. Bonchari Constituency
- E. KitutuChache North Constituency
- F. Kitutu Chache South Constituency
- G. Nyaribari Chache Constituency
- H. Nyaribari Masaba Constituency
- I. South Mugirango Constituency;

“Ward” denotes the area represented by a member of the County Assembly within County Government of Kisii;

“Ward Code” means the unique numbers given to the County Wards;

“Tax” shall refer to a compulsory financial contribution imposed by the County Government of Kisii within its jurisdiction;

“Treasury” means the County Treasury of Kisii;

That in order to have a smooth, transparent and equitable levy system for purposes of Schedule 1 the following meanings have been assigned to the following terms, where not specified:

- a) “Kiosk” – means a temporary structure occupying space equal to or less than 5M²
- b) “Small trader/ dealer” – shall be a business person occupying space equal to or less than 25 M²
- c) “Medium trader” – shall be a business person occupying over 25M² up to 60M²

- d) “Large trader” – shall be a business person occupying between 60M² and 225 M²
 - e) Mega – shall be a business person occupying between 225M² and 450 M²
 - f) Hypermarkets – shall be a business person occupying over 450M²
 - g) Small School – 1 - 50 students/Pupils.
 - h) Medium School – 51 - 150 students/Pupils.
 - i) Large School– 151 - 200 students/Pupils.
 - j) Extra Large Schools – above 200 students/Pupils.
 - k) The term ‘school’ shall refer to and include Early Childhood Development Education Centres, pre-primary, primary, secondary and driving schools.
 - l) The term “Higher learning institutions” shall refer to and include colleges, technical institutes and universities.
3. (a) The County Treasury shall for these purposes establish revenue collection centers within the sub-counties and Kisii Municipality headed by revenue officer who shall report to the Director Revenue who also reports to the Chief Officer.
- (b) That the County shall seek to seal all loopholes that promote corruption, tax evasion and loss of revenue.
- (c) There shall be a deliberate move to bring on board all stake- holders in discussing and getting involved in drafting this document for purposes of getting the harmonized licenses and levies in accordance with the Constitution of the Republic of Kenya 2010.
- (d) The County shall be at liberty to make such regulations as may be expedient for proper, prudent and frugal management and in accordance with the constitution of the Republic of Kenya 2010.

REVENUE SOURCE

In discharge of its mandate and suitability of its operations the county government proposes the following:

a. AGRICULTURAL PRODUCE FEES

- i. There shall be paid a levy to be known as agricultural produce fees on all tea, coffee, sugarcane, and other agricultural produce.
- ii. All processing factories are appointed as agricultural produce fee collection agents for the county government of Kisii.
- iii. The said factory produce agricultural produce fee shall be remitted to the County Government of Kisii on a Monthly basis.
- iv. The revenue receiver reserves the rights of access to books of accounts where necessary to determine such proceeds of a factory to ensure non-abuse of the 1% agricultural produce fee principle.

b. MINING CESS

There shall be established a levy on murram, hardcore and royalties to be effected at source. This levy shall be paid by the transporter.

c. SOAPSTONE CESS

In order to promote the growth of the soapstone industry, a special levy on value added products shall be levied at the exit point to be paid by operators.

In order to discourage the export of raw soapstone out of the source, a levy of raw soapstone shall be imposed at a flat rate.

d. OTHER CESS

- i. There shall be a levy to be known as Bricks, Hard-core, Ballast, Murram, Sand Harvesting, Farm produce, jaggery, poles, timber cess among others from source

to be levied at designated points of the County and to be pegged on the vehicle tonnage ferrying the products

- ii. The following are the designated points for purposes of levying cess and the agricultural produce fee: -
 1. Birongo, along Kisii –Keroka Road at Moturumesi junction
 2. Ichuni, along Keroka - Kilgoris Road
 3. Getare, at Nyatieko junction
 4. Kegogi, along Kisii –Miruka Road
 5. Mosochi, along Kisii-Oyugis Road
 6. Nyamira Market, along -Suneka –Homabay Road
 7. Riosiri Market, along Riorisi – Rongo Road
 8. Kamagambo, along Kisii - Rongo Road
 9. Nyangusu, at Kisii - Kilgoris Junction
 10. Nyamaiya market
 11. Maroo Market
 12. Birongo Chirichiro Road
 13. Tabaka junction at Nyachenge
- iii. The County Executive Committee Member may review the designated points from time to time by abolishing any existing point or introducing new ones. Any change of designated points shall be notified to the public through any appropriate mode of communication including a notice in the County gazette.

PART III**LEVIES, FEES AND CHARGES****4. Revenue sources**

- a) All fees, charges and licenses related to the Department of Trade, Tourism and industrialization under **SCHEDULE ONE**. These include single business permit, market dues, liquor license, weights and measures, etc.
- b) All fees and charges related to the Department of Lands, Physical Planning and Urban Development under **SCHEDULE TWO**. These include land rates, plot rent, land sub-divisions, property rates, development control fees, advertisements, penalties, etc.
- c) All fees and charges related to the Department of Water, Energy, Environment and Natural Resources under **SCHEDULE THREE**. These include environmental levies (cess) and permits, solid waste management, noise pollution permits, penalties, etc.
- d) All fees and charges related to the Department of Education, Labour and Manpower Development under **SCHEDULE FOUR**. These include registration and inspection fees for private learning institutions and day cares, etc.
- e) All fees and charges related to the Department of Agriculture, Livestock, Fisheries and Cooperative Development under **SCHEDULE FIVE**. These include market levy for stocks, public veterinary fees, slaughter fees, highland skin levies, farm produce cess, disease control fees, etc.
- f) All fees and charges related to the Department of Roads, Public Works, Transport and Housing under **SCHEDULE SIX**. These include Bus Park/Matatu/ Motorbike charges, parking charges, hire of plant and machinery charges, rent for houses, stalls, kiosks, associated penalties, etc.
- g) All fees and charges related to the Department of Public Health Services under **SCHEDULE SEVEN**. These include building plan certificates, food hygiene license, inspection fees, associated penalties, etc.
- h) All fees and charges related to the Department of Sports, Culture, Youth and Social Services under **SCHEDULE EIGHT**. These include hire of Gusii Stadium and other stadia, hire of social/culture halls, peoples' park, registration /renewal fees for social welfare groups, library services, associated penalties, etc.
- i) All fees and charges related to the Department of Disaster Management under **SCHEDULE NINE**. These include fire compliance certificates, inspection fees for vehicles with highly inflammable liquids and petrol stations, etc.
- j) All fees and charges related to the Department of Finance and Economic Planning under **SCHEDULE TEN**. These include sale of Acts and documents, associated charges and penalties, etc.

PART IV**ACCOUNTABILITY AND TRANSPARENCY**

- (1) The Executive Member for Finance shall assign targets on revenue collections on the Sub-Counties and Municipalities.
- (2) There shall be proper documentation of all monies collected as revenue on behalf of the County by the Revenue Officers and there shall be put in place cash registers.
- (3) It shall constitute an offence for any Revenue Officer to divert, or incur financial loss due to dishonesty, incompetence or malpractice for money received as revenue from the public for the County Government.
- (4) To protect its revenue bases, the CECM Finance shall take up the existing Revenue collection centers already in the county with such modifications as may be deemed necessary.
- (5) All persons newly employed and deployed as Revenue Officers and Revenue Accountants shall be vetted by the County Assembly's Budget committee for competence based on experience, skills, integrity, suitability and relevant training for deployment annually from the date of commencement of this Bill.
- (6) All Revenue Officers shall be responsible to the Revenue Directorate who is accountable to the Chief Officer Finance and CECM Finance.
- (7) All debts owed to the defunct local authorities shall be recovered by and paid to the County Government.
- (8) The Revenue Officer/and Revenue collector shall be held liable for any loss, stolen or unauthorized spending of revenue or and such money held by the officer.
- (9) Any person found culpable of such act (8 above) shall be dealt with in accordance with penal code and any other written laws.
- (10) The Departments have a responsibility to:
 - a) Identify revenue streams for purposes of increasing the tax base;
 - b) Come up with rules and regulations to support revenue collection;
 - c) Ensure that services incidental to revenue collection have been rendered.

PART V**TRANSITIONAL AND CONSEQUENTIAL PROVISIONS**

7. (1) All directions, resolutions, orders and authorizations on or relating to financial management, including the collection and administration of levies, fees and charges given or issued by the defunct local authorities and subsisting or valid immediately before the cessation of the application of the Local Government Act (now repealed) shall be deemed to have been given, issued or made by or under the authority of the County Assembly until the expiry, amendment or repeal of those directions, resolutions, orders and authorizations on financial management and shall continue, with the necessary modifications, apply to the payment and the administration of the levies, fees and charges under this Bill until the boards contemplated under Section 13 and 14 of Urban Areas and Cities Act are constituted.
- (2) Subsection (1) does not apply to the specific respective amounts payable in respect of the fees, charges or other levies and, in that regard the amount applicable shall be as provided for in the Schedules.
- (3) That any permit or receipt issued under the by-laws contemplated herein and were valid before the commencement of this Bill shall be deemed to be valid and issued under this Bill.

PART VI
PENALTIES

8. To effect and ensure compliance with this Bill and more specifically on the payment of the levies, fees and charges as per the schedules provided herein it is enacted as hereunder:
- 8.1. (a) The County shall do registration of all Businesses and properties within Kisii County. Failure to register will attract a penalty to the operator as per the Proposed fees and charges.
- (b) Single Business Permit issued expires on 31st December of every year.
- (c) Failure to apply and obtain a Single Business Permit by the **31st March of each year**, the fees chargeable shall attract a penalty of 5% of the SBP amount per month cumulatively.
- (d) That failure by a factory to remit cess as required within the stipulated period, the unpaid cess shall attract a penalty of 5% on the total cess withheld quarterly.
- (e) That the harvesting of sand, hard-core, marram and other royalties shall only be permitted after taking into consideration all relevant approval on environmental and public safety concerns from relevant bodies.
- (f) That it shall be an offence to excavate, dig and or mine any of the products named in (d) above without due regard to environmental and public safety concerns.
- (g) That it shall be the responsibility of the client to ensure that correct receipts/permits/licenses/stickers have been issued.
- (h) That any forgery or falsification of permits/licenses/receipts/stickers shall attract a fine not exceeding Fifty thousand shillings or imprisonment for a term not exceeding six months or both.
- 8.2 Any person who commits an offence under this Bill for which no penalty is provided shall be liable, on conviction, to a fine not exceeding Fifty thousand shillings or to imprisonment for a term not exceeding one year or both. The receiver of revenue shall determine such amounts in the absence of the County court.

PART VII

RULES

9. The Executive Committee Member for Finance in consultation with the County Executive Committee shall make rules to regulate the enforcement of the provisions of this Bill with approval of the County Assembly.

PART VIII**MISCELLANEOUS PROVISIONS**

10. The Kisii County Finance Bill, 2025 shall be operational within the boundaries demarcated as Kisii County by National Legislation.

10.1. REGULATIONS

- a) The Executive Committee Member for Finance may make regulations for better carrying out of the functions under this Bill for purposes of revenue collection.
- b) The Executive Committee Member for Finance and the County Chief Officer Finance/ Director Revenue Management shall design the format for forms, receipts, permits, licenses, invoice, demand notice and registers for revenue collection which are tamper proof.
- c) For avoidance of doubt the Executive Committee Member for Finance and the County Chief Finance/ Director Officer Revenue Management shall issue unique Business Codes in respect of all revenue streams.
- d) In computation of time, reference to hour, day, month, year shall be in accordance with the provisions of the Civil Procedure Act Cap 21 Laws of Kenya and Article 259 of the Constitution of Kenya 2010.
- e) Revenue collection is entrenched in this Bill as a 24 hour, seven days a week activity throughout the County.
- f) The Persons with Disabilities Act 2003 and The Persons with Disabilities (Income Tax Deductions and Exemptions) Order 2010, forms the legal basis for granting of exemptions on Single Business Permit (S.B.P) only for persons with disability.

The Executive Committee Member for Finance at the time may give people living with disability tax exemptions on **SBP ONLY** (*any other charges are excluded from this exemption*). However, this applies to waiver of not more than one business unit upon successful vetting and approval by the vetting committee appointed by the Executive Committee Member for Finance. ***The tax exemption accorded should not be extended to matters related to building plan approval.***

All applications **MUST** be received by **31st August** of each year in preparation for the next calendar year (revenue year).

- g) The unit of measure under this Bill shall be; within CBD, peri-urban, urban, sub-county, per hour, per instance, per day, per month, per term, per quarter per visit, per head, per square, per annum, per kiosk, per applicant, per trip, per tonnage, per plot, per metre square, per floor, per plan, per building, per piece, per basket, per heap, per bale, per box, per tin, per bunch, per depot, per store, per advert, per poster, per bundle, per copy, per fleet, per fortnight, per street, per house, per flat, per chair, per school, per business, per division, per property, per standard area, per dose, per booklet, per certificate, per letter, per lodging, per clinic, per test, per premise, per storage, per load, per permit, per document, per CBO, per acre, per extract, per night, per ft.
- h) On matters of impounded goods, levy/rates payer/offender shall be deemed to have forfeited his/her goods: (i) Perishable goods within 72 hours (ii) Durable goods within 6 months and therefore shall be disposed as per the Government Public Procurement and disposal Act 2015 without any further reference to the owner.

- i) Any damage/loss that may be as a result of impounding/seizure/shutting/towing of Motor vehicles, motor cycles, tuktuk or any other property as the case maybe, it shall be borne by the owner.
- j) Any dispute or complaint arising out of this Bill shall be referred to the Budget and Appropriation Committee of the County Assembly for hearing or redress before being referred to Court of Law for determination.
- k) In the absence of a county regulation on matters related to revenue management, the County Executive Committee member for Finance may seek approval from the County Executive Committee to carry out such function as may be deemed necessary.

10.2. OFFENCES

Any person or licensee who gives false information or makes false statement either orally or in writing in connection with a call of information made under this Bill or in connection with an investigation into the commission of an offence under this Bill, or abates the commission of the offence contemplated hereinabove commits an offence and is liable upon conviction to a fine or jail term for a term not exceeding three (3) years or to both as contemplated under the penalty section as per section (8.2) above.

PART IX**AMENDMENT TO THE SCHEDULES**

The Executive Committee Member for Finance may by order published in the Gazette amend any of the schedules in this Bill. Any order made under section (11) shall be laid before the County Assembly without unreasonable delay, and unless a resolution approving the order is passed by the County Assembly within forty-five days when the Assembly next sits after the order is so laid, the order shall lapse, but without prejudice to anything previously done there under.

NOTE:

For one to be issued with a Single Business Permit (SBP), they have to pay for the following charges:

Application/ Renewal fee, Permit fee, Waste Management Fee, Fire Compliance fee, Branding/ Wall writing/ Advertisement/ Billboards/ Signages (where applicable), Ground/ Plot rent and property land rates (where applicable), Arrears (where applicable)
